### Compensation assistance

If you have caused any damage while at work and are obliged to pay for this, we will provide advice and support in the form of compensation assistance.

### Car insurance excess

Have you been involved in an accident with your own vehicle on your way to or from work or a trade union event? We may be able to cover your excess up to a value of EUR 300 per claim.

### Legal protection

Are you facing criminal proceedings? If you do not have legal protection for criminal proceedings with another provider, you can rely on us. This also applies in the event of a dispute over a non-criminal offence.

### Assistance if you lose your keys

We won't leave you out in the cold, but will provide assistance if you are out of pocket as a result of their loss!

### Assistance for reduced earning capacity

Are you unable to work as a result of an occupational accident? We will give you EUR 12,000 in the event of a full reduction in earning capacity!

### Injury payment

If you have an accident and are unable to work for an extended period, your employer will stop paying you after 6 weeks. GUV/FAKULTA's injury payment goes some way to offsetting your loss of income. We help secure your standard of living – and possibly that of your family. For up to 400 days. At EUR 12 per day. Up to a maximum of EUR 4,800.

### When does GUV/FAKULTA provide assistance?

GUV/FAKULTA provides assistance in the event of injuries/damage incurred during occupational activity or accidents on the way to and from work and trade union events.

### Who can become a member?
