# Our top services at glance

- In case you have caused any damage at work and shall pay for it: We advise you and provide for support with an allowance for compensation of damages.
- You had an accident with your car on your way to or from work or another union-related event and now have suffered liability or own-damage? As may be the case, we assume a retained amount of up to 300 Euro per damage case.
- You might be prosecuted? If you don't have legal protection insurance for criminal proceedings from other institutions, you can count on us. This also applies to conflicts due to administrative offences.
- You have to enforce your own claims or repel claims from others? If you don't have legal protection insurance for civil proceedings from other institutions, you can count on us.
- You lost an office/work key and your employer demands e.g. that you pay for the replacement of the locking system? We will help you and, in justified cases, provide up to 150,000 Euro worth of allowance for damage compensation.
- Because of your work or service accident you must remain in a hospital? We will support you with up to 600 Euro. This also applies to accidents on the way to or from work.
- We help your spouse in case you are arrested as a result on an occupational activity.
- Because of a work or service accident you can no longer practice a profession or provide services? We help you with up to 12,000 Euro!
- We won't let you down and will help you in case you reached **financial distress** because of damages!
- In case of accidental death caused by an accident at work or during a service visit, we pay a non-recurring amount of 6,000 Euro to the surviving dependants and support them, if necessary, to safeguard their interests.

# When does GUV/FAKULTA provide support?

The GUV/FAKULTA provides support in case of damages that takes place in work-related settings, in case of accidents on the way to and from work and union-related events.

#### Who can become a member?

GUV/FAKULTA members can be employees or civil employees that are members of one of the united DGB (German Trade Union Confederation) unions. You can find more detailed information in the support regulations on our website.

### How much does the membership cost?

Stable contribution since 2008: 21 Euro per year, which are only 1.75 per month. By the way: The membership contribution fee is tax-deductible!
